- 1.2. The online store offers digital products only, specifically the e-book *Rabbit Genetics* in PDF format.
- 1.3. By placing an order, the Buyer confirms that they have read, understood, and agreed to these Terms.

### 2. Nature of Digital Products

- 2.1. All products offered are delivered exclusively as digital content in PDF format.
- 2.2. No physical item will be shipped.
- 2.3. The Buyer acknowledges that the product requires a device capable of opening PDF files.

### 3. Delivery of Digital Content

- 3.1. The digital product is delivered immediately after successful payment.
- 3.2. Delivery takes place via:
- a download link displayed on the order confirmation page, and/or
- an email containing the download link.
- 3.3. The Buyer is responsible for ensuring their device can open and store the PDF file.

### 4. License and Use

- 4.1. By purchasing the e-book, the Buyer receives a personal, non-exclusive, non-transferable license for private use.
- 4.2. The Buyer may not:
- copy, resell, or distribute the e-book,
- upload the file to public storage or sharing platforms,
- share the product with third parties,
- use the content commercially without written permission from the Seller.
- 4.3. Any unauthorized distribution may lead to legal action and termination of access.

# 5. Refund & Cancellation Policy

#### **5.1 United States**

- 5.1.1. Under U.S. law, digital products delivered via download are non-returnable.
- 5.1.2. All sales of digital products are final and non-refundable once the download link has been provided.
- 5.1.3. Refunds are issued only if:
- the PDF file is corrupted or unreadable, or
- the download link does not work and the issue cannot be resolved.

#### **5.2 United Kingdom**

- 5.2.1. Under the Consumer Contracts Regulations 2013, customers ordinarily have a 14-day right to cancel.
- 5.2.2. This right does **not** apply to digital content delivered immediately after purchase, provided the customer gives explicit consent.

Before completing the purchase, the Buyer must confirm:

"I agree to the immediate delivery of the digital content and acknowledge that I lose my 14-day right to cancel."

5.2.3. After the PDF download link has been delivered, no cancellations or refunds are possible.

# 6. Pricing & Payment

- 6.1. All prices are displayed in the currency shown on the website at the time of purchase.
- 6.2. Payments are processed securely through third-party payment providers (e.g., Stripe, PayPal).
- 6.3. The Seller does not store or process payment card information.

#### 6.4 VAT / Sales Tax

The Seller is registered for VAT identification purposes in Slovakia (VAT ID: SK1129612275) but is **not** a VAT payer.

Therefore, no VAT or sales tax is charged on purchases made through this website.

### 7. Technical Requirements

The Buyer must have:

- a device capable of opening PDF files,
- sufficient storage space,
- an active internet connection for downloading the product.

The Seller is not responsible for the Buyer's inability to open or use the file due to device limitations.

## 8. Limitation of Liability

- 8.1. The Seller is not liable for:
- losses caused by the Buyer's incorrect use of the product,
- damages resulting from circumstances beyond the Seller's control,
- loss of data after the file has been downloaded.
- 8.2. The Seller's maximum liability is limited to the purchase price of the e-book.

### 9. Governing Law

- For Buyers in the USA: These Terms are governed by the laws of the **State of Delaware**, excluding conflict-of-law rules.
- For Buyers in the UK: These Terms are governed by the laws of England and Wales.

Any disputes shall be resolved exclusively by the competent courts of the respective jurisdiction.
